President Jerry Morris called the meeting to order at 10:00 am.

Pastor Jim Raisanen shared an opening prayer.

Craig Kullberg conducted the balance of the meeting.

Secretary's Report:

There were no corrections. Patti Honnold made a motion to approve the minutes of the September 27, 2014 Annual Meeting. Lee Forrester seconded the motion and it passed.

A Thank You was issued to outgoing members: Jerry Morris, Sandy Pullen and Dale Siems for their service. Also a Thank You to Nancy Hansen and Randy Tofteland for their continuing service.

Election:

The candidates running are as follows: Melody Lackner a three year term, Lee Forrester a two year term and the one year term was not filled. Randy Tofteland nominated Sue Samuelson for the one-year term. Marge Garbo made a motion to accept the ballot unanimous, seconded by Mary Kramer-Long and the motion carried.

Auditors Report:

2015-16 Annual Report of the Pastor to the Bethesda Lutheran Church of Malmo

"The grace of the Lord Jesus be with all the saints. Amen" Revelation 22:21

This is the last verse in the Book of Revelation – which means these are the final and including words to the whole of Scripture. And how fitting it is that this brief Bible verse serves to provide the spiritual tenor and overlay to my concluding and last report to you, the blessed saints of Bethesda Lutheran Church of Malmo.

Sixteen years ago you and I began our journey together. I was the third fulltime pastor Bethesda had called having followed Pastor Paul Mattson and Pastor George Soruco. Previously, Bethesda had been yoked with Bethlehem Lutheran – Aitkin sharing pastor and parsonage expenses. Bethesda was formed by eight families in 1919 meeting in member's houses. In 1929 our first church building was located at Malmo Corners. In 1996 the base of our present building was dedicated and in 2007 our present facility came into being having added fellowship and meeting rooms. 2019 will be our Centennial celebration. We certainly have a lot for which to be thankful. God is good!

I sometimes wonder what our legacy will be in the history of Bethesda church. Will we be remembered for sharing the love of Jesus through our words and deeds? Will we be remembered for growing in our support of benevolent causes through our world and local giving? Will it be because of the way we did creation care (i.e. caring for lawn and gardens, memory garden, nature trail, playground, energy efficient updates, etc.)? Will we be remembered for building community and bringing people together through fellowship and worship opportunities (Jamboree, Bazaar, Celebration of Freedom, Beef & Corn feed, God's Work/Our Hands, Veggie stand)? Will our bible studies and men's and women's groups be of note? Will our music programs – our choir, praise team, bells, and special worship services be remembered? I know our friend Darwin Brusewitz will be remembered for sharing his special musical gifts. What a gift he was to our Bethesda church! So, I wonder about our legacy?

There are many, many of you I need to thank. For your love, acceptance, your ministry and willingness to work together I will be forever be grateful. Thanks to our church council and chairperson, Craig Kullberg, our committee chairpersons and members, our caretaker Judy Wourio, our choir and choirmaster Sheila Penoyer, our church secretaries, our treasurer Mary Braun and the many others who work behind the scenes in serving our Lord here at Bethesda. You have been a good team. Also, you should know that without my life partner Karen, I would not nearly have functioned as effectively as I did. Many thanks to her.

With this 2015-16 fiscal year now in the rearview mirror, I begin a series of "firsts". This will be my first retirement, my first time not having to attend council meetings, my first time I will not have to lead a Sunday morning worship service, the first Christmas in a long, long time I will be able to spend with my family.

At the completion of his earthly ministry, our Lord declared, "It is finished". On an infinitely smaller plan, in writing this report for you, the wonderful people of Bethesda Lutheran Church of Malmo, I too, feel I can rightly say, "It is finished". It's not completed for you - you have much to do - but my time in your midst, as your pastor - well, that is completed.

It has been great fun – truly. It has been an incredible delight serving with you as your shepherd. And, I can say without reservation, it has been the greatest honor and privilege of my life to have served as your pastor. As the scriptures conclude, so do I: "The grace of the Lord Jesus be with all the saints (at Bethesda). Amen" May God bless you richly, abundantly and always.

Letter from Council President

Dear Friends in Christ,

While looking back over this year I cannot imagine there is a more caring, loving, compassionate, and hard working congregation than ours at Bethesda Lutheran. I believe it all starts with our theme of "God's Work Our Hands" which symbolizes and embodies our mission statement. We are definitely living and serving through our faith, acting with love and kindness, and giving hope and support to all.

Our congregation has achieved numerous objectives this past year. Beginning with our focus of assisting one another on our faith journey, and helping each other enjoy life on a daily basis. I am proud to say the reincarnation of our "helping hands" group and the growth of our lay visitation program have made a huge impact on the lives of many in our congregation and the community as a whole. Our benevolence donations for global and local causes have exceeded \$20,000 once again this year, thus people near and far are benefitting from our charitable nature. Everyone's generous financial giving has also allowed us to invest in numerous capital improvements over the past year, with the largest project being the resurfacing of our parking lot. We have survived transitions in important areas of our ministry, which include our music program, veggie stand, committee leadership, and council member turnover. Additional fundraisers (AmazonSmile, Thrivent Financial, Darwin's music CD's) have been developed this year to help sustain our future budget in spite of our slightly declining active membership.

As usual, we have challenges to face this coming year. Our pastoral transition will certainly be the main focus as we begin our church fiscal year in September. Intertwined with our pastoral search will be the decision we make on the parsonage residence, because this issue will definitely influence the candidates interested in serving as our future full-time pastor. Other priorities will include the revamping of our website, promote increased participation from non-attending members, recruit a wider pool of volunteers to perform our ministries, and to develop a notable community project which illustrates the passion of Bethesda Lutheran to improve the lives of those who are not as fortunate as we are.

Pastor Jim constantly reminded us that our church is healthy for all the right reasons. It is not the nice facilities we enjoy, nor any one persons' position or accomplishments, rather the collective desire of every member of the congregation to care for each other in this journey we call life. I hope you are as proud to be an active member of Bethesda Lutheran as I am.

Mission and Evangelism

In 2016 we continued to promote World Hunger Program Events, Heifer Christmas Project, Equal Exchange coffee, food and money to food shelves, and Caring and Sharing Christmas Gift Cards to needy families. Our benevolence and veggie stand donations are divided among 5 local and 5 global charities.

This past year we updated and improved a new member information folder and updated gift bags to be used for new neighbor outreach. We planned and were able to get some media coverage for cleaning the beach on God's work our Hand's Sunday . Sandy Pullen gave a mission talk promoting Dara's Palliative Care Project in Mozambique .

We provided and Vacation Bible school experience for 46 children and 18 youth. We were able to get several articles about Bethesda's activities in local papers. Sandy collects and recycles ink cartridges. Our group works to facilitate Thrivent's program called Connecting Faith and Finances for Good. We deliver food donated to food shelf sites usually in Aitkin. During 2016 we were able to provide a new member directory with emails and phone numbers. We will continue to offer updated pages as we add new members. As new members join we add their names to neighborhood care groups.

Stewardship and Financial Committee

The goal of stewardship is to help God's people grow in their relationship with Jesus through the use of the time, talents, and finances God has entrusted to us.

During the next church year, the Stewardship Committee challenges each member to look at ways you can help serve not only Bethesda Lutheran, but in other areas of your life. We have each been given gifts to use for God's kingdom. Thank you to the many volunteers who have served during this past year in a host of areas. Without your countless hours of dedication, our church family would not be able to accomplish the tasks that needed to be done. As our church moves forward with help and guidance from our interim pastor, there will be opportunities for members to discern how our church is being called to serve and grow as disciples of Christ.

Along with the church council, we help monitor the finances of the church. After receiving input from committees, we develop a budget and recommend it to the council for approval.

The Giving Tree was developed a year ago to show how benevolence money is distributed. For the 2016-17 church year the council approved the following organizations and agencies to receive funding. Each of the groups will receive 20 percent of the gifts received. GLOBAL BENEVOLENCE FUNDS will be given to Dara, Mozambique; Village of Hope, Zambia; Ingrian Lutheran Church of Russia; Hope Lodge and Feed My Starving Children. LOCAL BENEVOLENCE FUNDS will be given to True Friends Camp at McGregor; Aitkin Social Services, Christmas Joy, BLCM Emergency Fund, and Camp Onomia.

If you haven't considered electronic giving, please talk to the financial director Barb Forrester. It is an easy way to have money deducted from your bank account and helps the church during the winter months when many members are gone. We also want to make you aware of donating stock. It is tax deductible and an easy way to donate to the church. The church treasurer can provide the account numbers for the transfer of stock.

The first Sunday of each month, Stewardship will hand out a newsletter with ideas on how each of us can be a better steward of God's gifts. There will be stories and ideas on what it means to be a disciple of Christ. We hope you enjoy the handout and will share it with others.

Stewardship takes this opportunity to thank Pastor Jim for his guidance over the past years. He has encouraged us to share our faith stories, to grow and learn as followers of Christ and to enjoy the fellowship we have with one another. The Faith, Health and Wellness committee consists of eight members. Our goal is to have a ministry that gives encouragement, comfort and a sense of belonging to people who are hurting, lonely or in need. We hope to provide physical, mental and spiritual wellness to the congregation.

Responsibilities of FHW are: Baby bundles, the loan closet, the military board, sending cards, making calls and doing visits, giving out prayer shawls and bereavement books, doing foot care and "Helping Hands. All things are going well. We gathered and gave, at baptisms, 16 baby bundles this year, the loan closet is scheduled to be cleaned and inventoried, the military board is up to date (thanks to Diane Jones), sending cards, since we added birthday and anniversary cards, is averaging about 50 cards per month, visiting and calling is done by three members who are enjoying this ministry very much, many bereavement books have been given out, foot care is going well, averaging about 5 people pre month, and helping hands has been called on and people have volunteered.

Parish Nursing

The Parish Nurse mission at Bethesda Lutheran Church of Malmo is to promote health and wellness of body, mind and spirit in the members of this congregation. We prayerfully request suggestions, thoughts, and ideas to help guide us as we seek to expand the Parish Nurse program to continually meet the ongoing needs of this congregation. Your suggestions are especially key as this past year and going forward the Parish Nurse program is in transition. The current membership of the Parish Nurse program includes Darlene Christensen, Patti Honnold and Kathy Berland (trained as official Parish Nurses) and Gloria

Christensen, Kathy Carlson, Kim Gourley (Foot Clinic) and, new to the program, Sherrie Whipple all with the support of Carolyn Morris, chair of the Faith, Health and Wellness Committee.

In an ideal world, especially while we address the appointment of an interim or permanent Pastor, the nurses would provide 100% of the services mentioned below. As personal responsibilities of the Parish Nurse staff have changed, some of the priorities need realistic adjustments. A major goal of this transition year is to ask the congregation to assist in determining the priorities expected from us.

Parish Nursing in an ideal world at Bethesda includes:

- 1. A monthly article in the Lifeline newsletter addresses current health issues and is written on a rotating basis by the nurses of the congregation.
 - The nurses received feedback that the Lifeline articles were not relevant and we stopped them last Winter
- 2. Personal and telephone counseling for health-related questions and concerns is offered by the nurses formally and informally in person or by phone. Advanced Directives completion assistance is also available.
- 3. Regular visits to nursing homes and assisted living sites in Onamia and Aitkin have continued. A home visit to shut-ins is provided as requested whenever possible by Kathy Berland and Carolyn Morris.
- 4. Hospital visits and home or telephone visits are available on request if staff is available. The Bethesda office staff will call one of us to assist in the visit.
- 5. The Cookie and Soup Ministry which provided cookies and soup to members who receive a visit has not been active. As we clarify the home visit process, we hope to reinitiate this activity.
- 6. Healing services are essentially on hiatus; one service was done this past year. This is an effort which is Pastor dependent and will be readdressed after that person has been identified.
- 7. The Foot Care Program continues with relative success. There are usually open appointments for this service; the suggested donation or \$10-20 covers a part of the cost. Kim Gourley is available throughout the year each month on the second Saturday of each month to provide foot and toenail care.
- 8. Some services, such as BP screening, have been dropped due to low participation.

Clearly with a limited staff of volunteers and a long list of tasks, we need some direction from the congregation as to what services you would like to have here at Bethesda. If you have a personal

need or an idea to assist our church members, please come to one of us or to Carolyn Morris for follow-up.

Worship and Music

Another great year at Bethesda. Our church year which goes from September 1, 2015 to August 31, 2016 was kicked off with a Jamboree performance of "We Are The World" on September 11th and 12th, 2015 with Val Benton as emcee.

Our annual potluck dinner and Thanksgiving service was held on Thursday, November 25th,2015. December was a busy month with the choir, under the direction of Sheila Penoyer presenting the Contata, "Touched by a Child, Touched by a King" by John Purifoy. Christmas services were held on Christmas Eve, Thursday, December 24th, 2015 at 3:30 and at 5:00 p.m. Christmas Day services were at 10:00 a.m.

During the winter months of January, February, and March one Worship service was held on Sundays at 9:00 a.m. due to the small congregation numbers. The choir also took the winter off.

Spring was celebrated with services on Palm Sunday, March 20th and two services on Easter Sunday March 27th, with the choir singing their praises. The Praise Team continued to sing through the year and showed us their talents. They sing the second Sunday of each month. The Bell Team is with us summer and fall. We miss them during the winter break but, look forward to them in the summer. Our organist, Marlys Beavers retired this year. We wish her and her family the best of wishes. Marilyn Samuelson, Linda Gommer, and Arty Heins played the electric piano for services.

With the ideas and leadership of Randy Tofteland the Worship and Music committee approved a new sound system. The digital organ was installed and is taking the place of an organist and is operated by volunteers from the congregation. So far nine people have been trained.

While Pastor Jim was on vacation or called away this year, Randy Tofteland, Val Benton, Pat Becker, Sheila Penoyer and John Ansell conducted the services. We are very proud to have John Ansell be a part of our services as a future Pastor, his future is bright and we know he will do well in Michigan.

John Koziol and his friend Sherrie along with Pat Balder were here for the Celebration of Freedom service in the 2nd and 3rd of July. They always draw a crowd of people.

The Garms Family Ministry presented their songs of Praise and talents to a full house on August 14th, 2016.
